Gwynedd Council, under, and by virtue of the powers vested in them in this behalf,  
DO HEREBY LICENCE the following Pleasure Boat to ply for hire within the  
limits of \*\*\*\*\* *Harbour* ( as specified in *MSN 1719 M* ) :-

This Licence to be in force from the *\*\*<sup>th</sup> of \*\*\*\*\* two thousand and ten*, up to the *31st day of \*\*\*\*\* , two thousand and ten* SUBJECT NEVERTHELESS to the provisions of the above-mentioned Acts, and also to such Byelaws, Rules, Orders and Regulations as are or shall from time to time be in force for the Regulation of Pleasure Boats plying for hire within the limits aforesaid, and as to the use of the Boat/Jetty belonging to the Council, and also upon and subject to the following conditions, namely:

1. That the Owner of the said Boat undertakes that the hull of the Boat is sound, and that the Boat is stable and its equipment complete and in good condition, and to the standards required by the Licensing Authority, and generally sufficient for the use in connection with a Pleasure Boat.
2. That the said owner undertakes that in all respects above-mentioned, the Boat, while it plies or is used for hire, shall be maintained in not less than its present state of efficiency.
3. That the said Owner undertakes that the Boat shall not carry passengers for hire unless a sufficient number of Boatmen duly licensed by Gwynedd Council to take charge of Pleasure Boats be employed in the navigation and management thereof.
4. That he/she will not permit any person other than a fully-licensed Boatman to ply for hire with any Licensed Pleasure Boat belonging to him/her.

5. The Licence is also granted on condition that the Licensee will not use or permit to be used the Boat hereby Licensed for the purpose of displaying any advertisement.
6. The Licensee will not permit the embarkation or disembarkation of passengers at any point other than from the point / points named on this license.

***Abermaw Harbour Categorized Waters area covered by MSN 1719 M Barmouth  
'Ferry Steps/Harbour Slipway/Ynys y Brawd or Pwynt Penrhyn.***

7. The Licensee shall not secure the vessel to the Ferry Steps (except in an emergency) for the purpose of embarking or disembarking passengers if another vessel is already berthed at the embarkation/disembarkation point. The departing vessel shall be given sufficient water to manoeuvre and clear the Ferry Steps before a Licensed vessel berths at the same point. A vessel which is not carrying or boarding/disembarking passengers shall not occupy the designated berthing area or hinder the berthing or departure of a vessel which is carrying passengers.
8. That if Gwynedd Council shall, pursuant to the power in that behalf vested in them by the above-named Acts, by notice in writing under the hand of their Proper Officer and addressed to the said Licensee, signify their intention to revoke this Licence on a breach of any of the above conditions, then this Licence shall from and after the date signified in such notice, cease and be void.
9. The Boat shall only be operated in favourable weather and with all passengers being seated at all times. The operator should ensure that the location of the passengers within the vessel does not adversely affect the trim of the vessel.
10. The maximum number of persons which may be carried on board the vessel and the rates of charges must be displayed clearly so as to be visible to the public before boarding the vessel, and such information shall also be clearly visible on board the vessel at all times whilst plying for hire.
11. That the owner ensures that the required level of safety apparatus is available at all times on the boat hereby licensed and may be inspected at any time by the appointed Council Official.
12. The Proprietor of the vessel shall indemnify Cyngor Gwynedd against any claim which may arise from the issuing of the licence or from any claim arising from the use of the harbour.
