Background

- 1 I attach a copy of Councillor Dawn Jones's application form, Member for Cadnant Ward, Caernarfon, Cyngor Gwynedd in relation to a Task Group that has been established by the Care Scrutiny Committee, which includes Members of the Education and Economy Scrutiny Committee.
- Councillor Dawn Jones had declared a prejudicial interest because individuals with whom she had a close personal connection were receiving the services that were the subject of the scrutiny. This was after obtaining the advice of the Deputy Monitoring Officer and corresponded with the advice I have given in a similar case.
- 3. The Standards Committee is entitled to grant a dispensation if the situation falls within one (or more) of the situations listed below:
 - "(a) if no fewer than half of the members of the relevant authority or of a committee of the authority (as the case may be) by which the business is to be considered has an interest which relates to that business;
 - (b) if no fewer than half the members of a leader and cabinet executive by which the business is to be considered have an interest that relates to that business and that either paragraph (ch) or paragraph (d) also apply;
 - (c) in the case of a county council or a county borough council, if a member's inability to participate would upset the political balance of the relevant authority or the committee of the authority by which the business is to be considered to such an extent that the outcome is likely to be affected;
 - (ch) if the nature of the member's interest is such that the member's participation in the business that the interest relates to would not damage the public's confidence in the way the relevant authority's business is undertaken;
 - (d) if the interest is common to the member and a significant proportion of the general public;
 - (dd) if the member's participation in the business to which the interest Page 4 relates is justified by the member's particular role or expertise;

- (e) if the business to which the interest relates to is considered by an overview and scrutiny committee of the relevant authority and that the member's interest is not a financial interest;
- (f) if the business which is to be considered relates to the finances or property of a voluntary organisation of which the member is a member of its management committee or board other than as a representative of the relevant authority and that the member has no other interest in that business provided that any dispensation shall not extend to participation in any vote with respect to that business; or
- (ff) if it appears to the committee to be in the interests of the inhabitants of the area of the relevant authority that the inability should be removed, provided that written notification of the grant of the dispensation is given to the National Assembly for Wales within seven days in such manner as it may specify."

I note that the application is made on ground (dd).

Background

- 4. I have consulted the Democracy Service to seek clarity on the role and purpose of the Task Group. The Task Group was established by the Care Scrutiny Committee in September 2023. It was to include five elected members, two nominated from the Education and Economy Scrutiny Committee. A copy of the Task Group's terms of reference is attached in Appendix 2. Please note that it is not within the role of a Task and Finish Group to call for evidence of a matter from users or experts. A scrutiny investigation would lead to this. A Task Group may make commendations to be considered by the Scrutiny Committee. It should be noted that a Task Group is a group of members who will review a field, and although they do not make decisions as such, their report will influence the direction of scrutiny in this field.
- 5. The establishing of the Task Group came about because of a presentation to the Care Scrutiny Community on the Autism Plan. In that meeting it was resolved to:

"Establish a Task and Finish Group to discuss implementing the Plan with the new team, ensuring representation from the Education Department and the Health Board"

6. In considering the application I also note that the Economy and Education Committee have recommended appointing the member and have recommended that they apply for a dispensation. Reserve members have been appointed.

The Ombudsman's Guidance

- 7. The Ombudsman's guidance on the Code of Conduct state the following in relation to dispensations in general:
- "3.51 Only the Standards Committee can grant the dispensation and will do so at its discretion. The Standards Committee will need to balance the public interest in preventing members with prejudicial interests from taking part in decisions, against the public interest in decisions being taken by a reasonably representative group of members of the Council."
- 8. Any further information that will have been received regarding the applications will be presented in the meeting.

The Application

- 9. A Task Group is considered a "meeting" according to the definition in the Code of Conduct. I note that the fact that a meeting makes decisions or not is irrelevant to the definition of "meeting".
- 10. The interest arises from a matter that affects the well-being of individuals with whom the member has a close relationship, namely grandchildren who are receiving the service in question in an educational context. This is one of the aspects that the Working Group is specifically addressing.
- 11. Although Dawn Jones works for Sylfaen Cymunedol, a company that delivers community projects to support young people across Anglesey, Conwy and Gwynedd which inevitably comes into contact with young people with autism, having discussed with the member it was not considered that the nature or level of this involvement is affected by what is in question.
- 12. The application is made on the grounds that Councillor Dawn Jones has expertise in the field of autism due to her particular role or expertise. The explanation of the grounds for this statement is explained in the application. I note that it will not be the Task Group members' role to advise or give guidance.
- 13. My guidance is that the ground of expertise and role should be considered carefully, and that the member must be able to demonstrate a recognised expertise in a field or role that has a recognised status.

Summary

14. The question of the working group's role or the fact that a personal prejudicial interest exists is not the matter at hand. This is implied in a dispensation application. What the Committee is required to consider is whether there are clear grounds for granting the dispensation, on what conditions, and where does the balance of the public interest fall against Personal Interest.

The Committee could:

- 1. Approve the application
- 2. Approve it partially e.g. allow participation in some particular circumstances
- 3. Refuse the application

Recommendation

The Committee is asked consider and decide on the application

Appendix 2

TASK AND FINISH GROUP AUTISM PLAN BRIEF

What matter is being considered?

An update on the Gwynedd Autism Plan was presented to a meeting of the Care Scrutiny Committee on 20 April 2023. An update was submitted on the ongoing work, including an update on staffing, awareness raising steps, training and working in partnerships. In addition, the Cabinet Members responsible for Children and Adults Services submitted the priorities for the coming six months.

There were responses provided to several issues raised during the committee meeting, but some additional issues arose about the individual's experience when awaiting a diagnosis, frustration in the community regarding diagnosis waiting lists and a lack of clear understanding of the support available in schools following receiving a diagnosis.

The committee decided that they were keen to establish a task and finish group to discuss the matter further and requested that representatives from the Department of Education and the Health Board should be present to answer their concerns. It was also decided to extend an invitation to representatives of the Education and Economy Scrutiny Committee as the work bridges the work areas of both committees.

The purpose of the work is to ensure an understanding of the implementation of the Gwynedd Autism Plan as a whole, including:

- an understanding of the support available to individuals and their families when awaiting a diagnosis, and whether there are any barriers on the road to a diagnosis and
- following diagnosis, in particular the support available for children within our schools, and whether there are any barriers.

<u>Actions</u>

- Care Scrutiny Committee to receive the brief and identify three Members to participate. (21/09/2023)
- Invite representatives from the Education and Economy Scrutiny Committee (two members) to participate. We will correspond with members of the Education and Economy Scrutiny Committee by email following the Care Scrutiny Committee's decision on 21/09, formally confirming membership at the Education and Economy Scrutiny Committee meeting on 09/11/2023.

- Hold a meeting for the five members with representatives from the Children, Adults and Education Departments, and a representative from the Health Board. (Exact date to be confirmed following a discussion with key partners anticipated end of 2023/beginning of 2024).
- Report back to the Care Scrutiny Committee 1 February 2024 (depending on the date of the above meeting).

Background

- 1. I attach a copy of the application form of Councillor Gwynfor Owen, Harlech and Llanbedr Ward Member, Cyngor Gwynedd, in relation to a Task Group that was established by the Care Scrutiny Committee including Members from the Education and Economy Scrutiny Committee.
- 2. Councillor Gwynfor Owen who is a member of both Scrutiny Committees declared an interest that was prejudicial, as individuals that he had a close personal association with, namely his son, received the services that were subject to the scrutiny. This was after receiving advice from the Deputy Monitoring Officer and is in line with the advice that I had given.
- 3. The Standards Committee is entitled to allow dispensation if the situation falls within one (or more) of the situations listed below:
 - " (a) no fewer than half of the members of the relevant authority or of a committee of the authority (as the case may be) by which the business is to be considered has an interest which relates to that business;
 - (b) no fewer than half of the members of a leader and cabinet executive of the relevant authority by which the business is to be considered has an interest which relates to that business and either paragraph (d) or (e) also applies;
 - (c) in the case of a county or county borough council, the inability of the member to participate would upset the political balance of the relevant authority or of the committee of the authority by which the business is to be considered to such an extent that the outcome would be likely to be affected;
 - (d) the nature of the member's interest is such that the member's participation in the business to which the interest relates would not damage public confidence in the conduct of the relevant authority's business;

- (e) the interest is common to the member and a significant proportion of the general public;
- (f) the participation of the member in the business to which the interest relates is justified by the member's particular role or expertise;
- (g) the business to which the interest relates is to be considered by an overview and scrutiny committee of the relevant authority and the member's interest is not a pecuniary interest;
- (h) the business which is to be considered relates to the finances or property of a voluntary organisation of whose management committee or board the member is a member otherwise than as a representative of the relevant authority and the member has no other interest in that business provided that any dispensation shall not extend to participation in any vote with respect to that business; or
- (i) it appears to the committee to be in the interests of the inhabitants of the area of the relevant authority that the disability should be removed provided that written notification of the grant of the dispensation is given to the National Assembly for Wales within seven days in such manner as it may specify."

It was noted that it was on the basis of (d) (f) (g) that the application was made.

Background

- 4. I have consulted the Democracy Service to obtain clarity in terms of the role and intention of the Task Group. The Task Group was established by the Care Scrutiny Committee in September 2023. It was to include 5 elected members, 2 nominated from the Education and Economy Scrutiny Committee. A copy of the Task Group's terms of reference is attached in Appendix 2. Please note that it is not within the role of a Task and Finish Group to call for evidence of a matter from users or experts. A scrutiny investigation would lead to this. A Task Group may make recommendations to be considered by the Scrutiny Committee. It should be noted that a Task Group is a group of members who will review a field, and although they do not make decisions as such, their report will influence the direction of scrutiny in this matter
- 5. Establishing the Task Group arose from a presentation to the Care Scrutiny Committee on the Autism Plan. In the meeting it was decided to:

"Establish a Task and Finish Group to discuss implementing the Plan with the new team, ensuring representation from the Education Department and the Health Board"

6. When considering the application, it was also noted that the Education and Economy Committee had recommended appointing the member to the Task Group and had recommended that they made an application for dispensation. Reserve members have been appointed. I also need to highlight that Councillor Gwynfor Owen's application for a general dispensation which would allow him to speak and vote on the matter on any occasion it arose.

The Ombudsman's Guidelines

- 7. The Ombudsman's guidelines on the Code of Conduct note the following in relation to dispensations in general:
 - "3.51 Only the Standards Committee can grant the dispensation and will do so at its discretion. The Standards Committee will need to balance the public interest in preventing members with prejudicial interests from taking part in decisions, against the public interest in decisions being taken by a reasonably representative group of members of the Council. ..."
- 8. Any further information that has been received regarding the applications will be presented in the meeting.

The Application

- 9. A Task Group is considered a "meeting" according to the definition of the Code of Conduct. It was noted that the fact that a meeting made a decision or not was not relevant to the definition of the "meeting".
- 10. The interest derives from a matter that affects the wellbeing of individuals with whom the member has a close relationship, namely his son who receives the service in question. This in the context of education, which is one of the aspects that receives attention from the Working Group specifically.
- 13. My guidance is that the basis of expertise and role should be carefully considered and that it is necessary to be able to demonstrate recognised expertise in a field or role that has a recognised status.
- 14. In terms of the other grounds, I ask the Committee to consider the application and come to a view on the matter.

Summary

15. The question of the role of the working group, or the fact that there is a prejudicial personal interest, is not before us. This is implicit in an application for a dispensation. What the Committee is required to consider is whether there is a clear basis for granting a dispensation, on what conditions and where the balance of the public interest falls against Personal Interest.

The Committee could:

- 1. Approve the application
- Approve it partially, e.g. allow participation in some particular circumstances
 Refuse the application

Appendix 2

TASK AND FINISH GROUP AUTISM PLAN BRIEF

What matter is being considered?

An update on the Gwynedd Autism Plan was presented to a meeting of the Care Scrutiny Committee on 20 April 2023. An update was submitted on the ongoing work, including an update on staffing, awareness raising steps, training and working in partnerships. In addition, the Cabinet Members responsible for Children and Adults Services submitted the priorities for the coming six months.

There were responses provided to several issues raised during the committee meeting, but some additional issues arose about the individual's experience when awaiting a diagnosis, frustration in the community regarding diagnosis waiting lists and a lack of clear understanding of the support available in schools following receiving a diagnosis.

The committee decided that they were keen to establish a task and finish group to discuss the matter further and requested that representatives from the Department of Education and the Health Board should be present to answer their concerns. It was also decided to extend an invitation to representatives of the Education and Economy Scrutiny Committee as the work bridges the work areas of both committees.

The purpose of the work is to ensure an understanding of the implementation of the Gwynedd Autism Plan as a whole, including:

- an understanding of the support available to individuals and their families when awaiting a diagnosis, and whether there are any barriers on the road to a diagnosis and
- following diagnosis, in particular the support available for children within our schools, and whether there are any barriers.

<u>Actions</u>

- Care Scrutiny Committee to receive the brief and identify three Members to participate. (21/09/2023)
- Invite representatives from the Education and Economy Scrutiny Committee (two members) to participate. We will correspond with members of the Education and Economy Scrutiny Committee by email following the Care Scrutiny Committee's decision on 21/09, formally confirming membership at the Education and Economy Scrutiny Committee meeting on 09/11/2023.

- Hold a meeting for the five members with representatives from the Children, Adults and Education Departments, and a representative from the Health Board. (Exact date to be confirmed following a discussion with key partners anticipated end of 2023/beginning of 2024).
- Report back to the Care Scrutiny Committee 1 February 2024 (depending on the date of the above meeting).
