PURPOSE:

- To plan and co-ordinate a joined up strategic approach to energy across North Wales, including development of the Regional Energy Plan.
- To plan and co-ordinate the delivery of strategic interventions, including relevant Growth Deal projects under the Low Carbon Energy Programme.
- To report to the NWEAB on progress, performance, outcomes and funding issues.

RELATIONSHIP WITH ECONOMIC AMBITION BOARD:

- The Chair of the Sub-Group will be invited to meetings of the NWEAB to report on progress, performance and outcomes.
- The Sub-Group will require relevant updates from project sponsors for each of the Low Carbon Energy projects, namely Morlais, Smart Local Energy Networks, Trawsfynydd Power Station and the Nuclear Centre of Excellence.
