### I. INTRODUCTION

1.1 This report is a progress report on completion of the 2010/11 internal audit plan.

### 2. SUMMARY OF PROGRESS AGAINST THE PLAN

2.1 The 2010/11 internal audit plan is included in the appendix to this report, with the current status of the work shown, together with the time spent on each project as at 5 September 2010. The current status of the work in the operational plan is as follows:

2.2 The performance target for 2010/11 is to have 85% of the audits in the plan to be either closed or with the final report released by 31 March 2011. The quarterly profile of this indicator is as follows:

- 2.3 In order to reach the target for the end of the second quarter, it is expected that final report of the following will have been released by 30 September in addition to the 15 final reports that have already been issued:
  - Ysgol Botwnnog
  - Ysgol Tryfan
  - The Printroom
  - Capital Accounting
  - Preparations for IFRS Leases
  - Device Management
  - Records Management Unit
  - Glan Wnion Leisure Centre

- Costs of Public Toilets
- Road Condition Inspection and referreals by the public
- Final Accounts: Gwynedd Consultancy (A499 Scheme)

### 3. AMENDMENTS TO THE PLAN

- 3.1 As can be seen, the plan in the Appendix contains some amendments to the original plan.
- 3.2 A review of the use of external translators has been included in this year's plan at the request of the Democracy and Legal Department. As a result, the scope of the review of land charges, which has a lower priority than other audits in the plan, has been reduced, with the number of days earmarked for the audit also reduced, to 5 days.
- 3.3 Retention monies remain payable on a number of contracts for works undertaken on the housing stock before its transfer to GCH. During 2010/11 Internal Audit will review the retention on these contracts (which remain the responsibility of Gwynedd Council) in order to ensure that correct payments are made to the relevant contractors. It is envisaged that 20 days will be required in 2010/11 to achieve this; in order to find this resource a review of the Joint Provision of Environmental Services has been put back to 2011/12. It is not considered that this delay of a few months will present the authority with significant additional risks.
- 3.4 The development of the new Ysgol yr Hendre presents the authority with several risks. The revised 2010/11 plan contains 15 days to review the process of inviting expressions of interest and tenders, and the scoring methodology fod pre-qualification questionnaires and tenders. These days were found by reducing the scope of the "Amgylchedd o Ansawdd" audit following consultation with the relevant chief officer, thereby reducing the required number of days from 20 to 5.
- 3.5 A request was received from the Assembly Government, via the Education Department, for an audit of the Innovation in Small Schools grant. In 2009, Internal Audit had reviewed the grant in accordance with the grant conditions and had informed the Assembly Government – also within the terms and conditions – that no further review would occur for another 3 years. However, as the grant came to an end in 2010, a request was received for a further review. In order to find time to allocate for this work, the time allowed for the School Trips audit has been reduced from 25 to 22 days; it is believed that 22 days remains adequate for this audit.
- 3.6 In order to increase the time earmarked to audit Gwynedd Consultancy's final accounts and in particular the A499 Aberdesach to Llanaelhaearn contract from 5 days to 10 days, the scope of the audit of the Integrated Transport Unit was revised, with an equivalent reduction in the required days for that audit, down to 20 days.

#### 4. **RECOMMENDATION**

4.1 The Committee is asked to note the contents of this report as an update on progress against the 2010/11 audit plan, offer comments thereon and accept the report.
