#### I. INTRODUCTION

1.1 This report is a progress report on completion of the 2011/12 internal audit plan.

# 2. SUMMARY OF PROGRESS AGAINST THE PLAN

2.1 The 2011/12 internal audit plan is included in the appendix to this report, with the current status of the work shown, together with the time spent on each project up to 31 October 2011. The current status of the work in the operational plan is as follows:

The three audits that have been cancelled are:

- CYNNAL Joint Audit with IoACC
- Outlook Web Access Security
- Social Worker Training

The reasons for this are found in Part 3 of this report, "Amendments to the Plan".

- 2.2 The 30 days that had been allocated previously to *Grants (Environment Group)*, has now been disaggregated into 6 discrete 5-day audits.
- 2.3 The performance target for 2011/12 is to have 95% of the audits in the plan to be either closed or with the final report released by 31 March 2012. In line with the indicator's profile, the target for the end of quarter 3 is 60%.
- 2.4 As seen from the table above, Internal Audit's actual achievement up to the end of October 2011 was 46.9% out of 113 individual audits contained in the 2011/12 revised plan, 51 had been released in a finalised version by the end of the month, and another two audits had been closed. In order to meet the profile, the final reports of a further 15 audits will need to be released by the end of the December 2011 (that is, 68 out of 113). It is expected that this will be achieved.

# 3. AMENDMENTS TO THE PLAN

- 3.1 Approximately 2 days of advisory and guidance has already been used on *Contract Management - Blaenau Ffestiniog Regeneration Scheme*, but due to the timetable of the scheme it was concluded that a further audit in the early months of the 2012/13 audit year would be appropriate. As a result, an 8-day audit of *Contractor Selection – Coastal Defence* has been added to plan.
- 3.2 The Committee will be aware of previous work that had been undertaken by Internal Audit at Bro Ffestiniog Leisure Centre and Swimming Pool. The management of this centre has been split, with the swimming pool remaining with the Provider and Leisure Department, but management of the Sports Hall has been transferred to Ysgol y Moelwyn. Because of these changes, and the new systems that the school are introducing at the centre, it was concluded that a full audit would be beneficial during 2011/12, rather than a follow-up as originally planned (a follow-up has already been undertaken on the Swimming Pool). In order to find the resources to undertake this work, it is suggested that the audit of Cynnal, to be undertaken jointly with Isle of Anglesey County Council internal audit, is postponed; this work has not yet started.
- 3.3 The original plan included a review of the risks presented by the use of "Outlook Web Access", a system that allows remote access to the Council's e-mail system. When performing an assessment during the year, however, it became apparent that potentially greater risks are presented by the use of information technology in schools. As a result, the "Outlook Web Access" Security audit will not be undertaken during 2011/12, with an audit of *IT Security in Schools* performed instead. Further consideration will be given to "Outlook Web Access" security when planning the 2012/13 work programme.
- 3.4 Following further discussions with the Housing and Social Services Department, it was concluded that an audit of Social Worker Training would not be a beneficial use of Internal Audit resources. This matter had been suggested by that department's Audit, Quality and Performance Group as an area in which Internal Audit could assist, but following research into the issue, it was not clear that Internal Audit could add value at this stage. As a result, 18 days were transferred from this audit to the Education Department's plan, so that audits could be undertaken on two grants the School Uniform Grant and the Pilot Projects Relating to Behaviour and Attendance Grant (9 days each).

# 4. **RECOMMENDATION**

4.1 The Committee is asked to note the contents of this report as an update on progress against the 2011/12 audit plan, offer comments thereon and accept the report.
