### **APPLICATION**

#### **Bangor City Council**

An e-mail was received from the Council’s Clerk objecting to the application based on the licensing objectives of preventing crime and disorder and public nuisance. It was noted that the proposed hours would lead to an increase in crime and disorder, as well as an increase in nuisance, noise and litter on the street.

#### **North Wales Police**

The Police do not object to the application for an extension of hours. It is noted that the Police request that conditions be imposed on the licence with regard to CCTV and Door Supervisors. See full details of the objections attached to the report.
