CRIMINAL JUSTICE AND POLICE ACT 2001

ALCOHOL CONSUMPTION IN DESIGNATED PUBLIC PLACES (BETHESDA, COUNTY OF GWYNEDD) (NO 1) ORDER 2011

Gwynedd Council (in this Order referred to as “the Council”) hereby makes the following Order under Section 13(2) of the above Act:

1. The land described in the Schedule below and shown on the map attached to this Order, being a public place in the area of the Council and a public space in which the consumption of alcohol has been associated with disorder, nuisance or annoyance to a member of the public or a section of the public, is hereby designated for the purposes of Section 13(2) of the above Act.
2. This Order may be cited as the Alcohol Consumption in Designated Public Places (Bethesda, County of Gwynedd) (No 1) Order 2011 and shall come in to force on [insert date].

SCHEDULE

All streets, roads and other lands to which the public have access in the town centre of Bethesda, Gwynedd within the area more particularly delineated and edged red on the plan ‘CG1’ attached to this Order, including inter alia High Steet, Glan Ffrydlas, Pant Road, Rhos-y-Nant, Glan Ogwen, Llawr y Nant, Abercaseg, Abercaseg Road, Bryn Caseg, Treflys Street, Goronwy Street, Well Street, Gerlan Road, Pen-y-Clwyt, Morgan Street, Hill Street, Upper Hill Street, Short Street, Pant Glas Road, Garneddwen, Maes Garnedd, Adwy’r Nant, Llain Deg, Pen y Bryn Road, John Street, Rhes Tabernacl, Ogwen Street, Glanafon Street, Victoria Square, Bryntirion, Coetmor Road, Bangor Road and Parc Meurig.
