- 1. At its meeting on the 17th May, 2012 the Council adopted a new Constitution.
- 2. The Constitution established a Language Committee with 15 Council members on a political balance basis but it did not contain terms of reference for the Committee.
- 3. Following discussions with relevant members and officers, terms of reference can now be recommended for the committee and these can be seen in Appendix '1'.
- 4. Under the regulations dealing with employing officers, appointments to the post of departmental head or directors are made by committee, appointment of a Chief Executive is made by full Council and all other appointments are made by officers. As the post of Head of Housing and Social Services will become vacant in the coming weeks, the Council is requested to establish a Chief Officers Appointments Committee, consisting of 15 Council members on the basis of political balance with the terms of reference recommended in Appendix '2'.
- 5. Due to the urgency to appoint to the post in question, the Council is requested to delegate to the Committee, the right to consider all the options to fill the post including, for example, restructuring, and to come to a decision on the most appropriate method and then to act upon it.

## 6. **RECOMMENDATION.**

The Council is asked to:-

- a) adopt the terms of reference in Appendix '1' for the Language Committee;
- b) establish a Chief Officers Appointments Committee with the terms of reference in Appendix '2' and which includes 15 members of the Council on the basis of political balance;
- c) authorise the Monitoring Officer to make the necessary amendments to the Constitution to give effect to the decisions;
- ch) delegate to the Chief Officers Appointments Committee for the post of Head of Housing and Social Services, the power to consider, come to a decision and act on the most appropriate way to fill the post.
