I Background and purpose

- 1.1 The Councils' programme to prepare the Joint Local Development Plan (LDP) has been included in the Delivery Agreement approved by the two Councils by November 2011. The Agreement was supported by the Government in November 2011
- 1.2 The report updates the Committee of the progress made so far in the process of preparing the Joint LDP. It provides information about the technical studies being carried out as well as work on associated topic papers. The report also seeks support for the amended timetable.

2 Progress so far

- 2.1 Table I in Appendix I sets out the statutory milestones in the process of preparing the Joint LDP. This is what is included in the Delivery Agreement.
- 2.2 We are currently in the middle of stages 2 and 3 namely reviewing and developing the evidence base, which includes input from the public and other stakeholders. This is the period when a great deal of evidence is collected that will influence the contents of the Joint LDP.
- 2.3 Table 2 in Appendix I shows the lower tier milestones that allow us to achieve the statutory steps noted in Table I.
- 2.4 Table 3 in Appendix 2 provides information regarding technical studies and topic papers.

3 Diary of reports to committees in 2012

3.1 Table 4 in Appendix 3 shows the proposed order of reporting and the relationship between the Joint Planning Policy Committee and other relevant committees.

- 3.2 We will aim to submit part of the Pre-deposit Plan to the Joint Planning Policy Committee in September and the full Pre-deposit Plan to it in November 2012. Table 4 indicates that the Pre-deposit Plan will not be ready for public consultation until the end of December 2012.
- 3.3 Although significant progress has been made in the work of collecting and analysing evidence, a number of matters have affected the timetable, leading to a slight slippage of 3 months. These matters include:
 - the significant response to the call for sites period with a very high percentage of the information being submitted during the last fortnight of the period. Each of the sites had to be processed and each one had to be assessed too;
 - having to divert resources to other fields of work, e.ge. preparation of SPG regarding land-based Renewable Energy and response to the public consultation;
 - periods of long-term sickness in the Joint Planning Policy Unit
- 3.4 Table 5 in Appendix 4 notes the amended timetable for the process of preparing the Joint LDP. Note that every effort will be made to adhere to this amended timetable for 2012 2013 and to look for opportunities to reduce the slippage from April 2013 onwards. The Welsh Government has already been informed of the slight slippage, the reasons for it and the steps being taken to remedy the situation.
