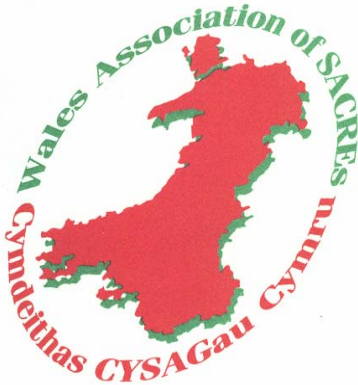

Quiet reflection With the forthcoming Olympic games in China almost upon us, the Chair asked members to reflect for a short while on:</p> <ul style="list-style-type: none"> a) those in southern China who had lost loved ones, livelihoods and property as a result of the terrible earthquake there, and b) those in Tibet who continue to actively struggle to protect their identity, culture and religion.

He commented on his pride in the work of the Flintshire SACRE and the work of their RE advisor, Gavin Craigen who has contributed so much to Flintshire, other LEAs in North Wales and Wales in general. The Chair thanked Mr Davies for the hospitality extended to the meeting.</p>

Her appointment was also fully endorsed by members of the meeting.</p> <p>In his role as new Chair of WASACRE, the Chair recognised that it was a privilege to serve the Association, further its good name and reputation and continue to provide a high profile to the subject at a national level. He noted his conviction that RE was the most interesting and exciting subject on the school curriculum but drew attention to the significant and challenging changes facing the subject at this time in Wales.</p> <p>It was agreed that a letter should be sent to Gavin Craigen and Susan Collingbourne, thanking them for their most valuable contributions during their periods of office. Minutes of the meeting held at Carmarthen, 14 March 2008</p> <p>The minutes were accepted as a true record of that meeting with three amendments which were agreed:</p> <ul style="list-style-type: none"> (i) page 3, point 3, final sentence – RE Today to be changed to RE News; (ii) list of those present at meeting and apologies (facing page) – Gwyn Rodgers and Eurfryn Davies to be added as present.

Matters arising A number of matters arising were also agenda items and were considered at the appropriate points on the agenda.</p> <p>Page 2, point 3 – Tania ap Sion confirmed that REflections had been posted to LEAs.</p> <p>Pages 2-3, point 7, bullet point 1 – a letter and e-mail from Jon Hawkins and an e-mail from Morfudd Roberts from WAG were included in members' papers in relation to the revised information and planning sheet. As the correspondence indicated, the issue of RE being properly included in Foundation Stage training materials had now been addressed. RE is now included as a subject on the planning sheet. Comments were made by several members about the disappointment that the issue of RE had not been addressed earlier but welcomed the positive outcome.</p> <p>Page 3, point 7, bullet point 2 – A copy of the letter from Susan Lewis was circulated, for information. The Chair welcomed Estyn's assurance of consultation with WASACRE and suggested that this should be monitored. It was noted that a WASACRE representative was a member of the Estyn forum and monitoring might be undertaken by this means.</p> <p>Page 3, point 7, bullet point 6 – Rheinallt Thomas noted that although UCAC had indicated that incorrect comments concerning collective worship in its magazine, 'Yr Athro' would be addressed, nothing had as yet appeared. There was continuing concern that some UCAC members had been misled. The Chair offered to contact the Union to</p>

Some SACRE representatives responded that they had received this letter, while others had not. Members were asked to check this issue with their SACREs.</p> <p>Page 6, point 11, bullet point 2 – Vicky Thomas reported that a response had been received from WAG, but was disappointed that the issues had not been addressed. She informed members that materials are automatically sent to schools in England but had to be requested in Wales, and there was no Welsh language edition. It was agreed that Vicky Thomas would liaise with the Secretary and a letter be sent to the WAG to request funding to address the imbalance in provision.</p> <p>Page 7, point 11, bullet point 5 – It was noted that a letter to SACREs regarding attendance had been sent. Members felt that it would be valuable to have the presence of teacher representatives at meetings and explored a variety of problems which prevented this. It was agreed that another letter should be sent to Directors of Education, SACRE Clerks, Council Leaders and Chairs of SACREs in each LEA requesting an improvement in attendance and emphasising the importance of LEAs meeting the necessary expenses to facilitate teacher representation at WASACRE.</p>

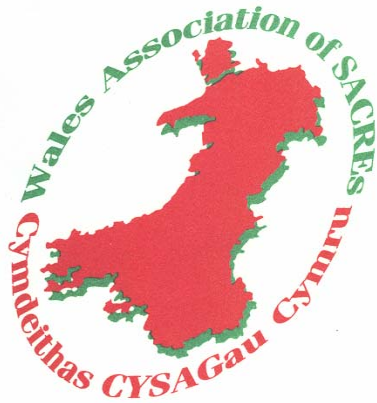

Cyflwyniad Oherwydd absenoldeb Denize Morris, croesawodd y Cadeirydd Gwenan Roberts ac Iestyn Griffiths o Gyrfaoedd Cymru i roi cyflwyniad ar 'AG a byd gwaith'.</p> <p>Crynodeb: I gychwyn, amlinellwyd y cyd-destun i waith Gyrfaoedd Cymru. Un agwedd ar ei waith mewn perthynas â phartneriaethau rhwng addysg a busnes oedd darparu lleoliadau datblygiad proffesiynol. Yr oedd y lleoliadau datblygiad proffesiynol yn agored i athrawon cynradd ac uwchradd ac i ddarlithwyr Addysg Bellach. Yr oedd y lleoliadau'n digwydd ar safle mewn busnes, cwmni neu sefydliad perthnasol, a gallent ddigwydd ar unrhyw adeg yn ystod y flwyddyn academaidd. Amcanion cyffredinol y lleoliadau oedd: datblygu cysylltiadau rhwng addysg a busnes; diweddarau gwybodaeth a dealltwriaeth ynglŷn â diwydiant; datblygu sgiliau ymhellach ar gyfer addysgu mewn pwnc penodol; a hybu datblygiad proffesiynol a phersonol. Disgrifiwyd nifer o enghreifftiau o leoliadau, gan gynnwys Llwybr Ffydd Lerpwl a'r ganolfan aml-ffydd yn Ysbyty Gwynedd, Bangor.</p> <p>Yr oedd y themâu perthnasol ar gyfer lleoliadau AG yn cynnwys ymchwilio i gydraddoldeb ac amrywiaeth yn y gweithle, masnach deg, gwirfoddoli, a gwaith yn ymwneud â byd natur.</p>	<p>7. Presentation Given Denize Morris' absence, the Chair welcomed a presentation on 'RE and the world of work' by Gwenan Roberts and Iestyn Griffiths from Careers Wales.</p> <p>Summary: Initially, the work of Careers Wales in general was contextualised, and one aspect of its work in relation to education business partnerships was the provision of professional development placements. The professional development placements are open to primary and secondary teachers and FE lecturers. The placements take place on-site at a relevant business, company, or organisation, and these can take place at any time in the academic year. The aims of the placements are: to develop education business links; to update knowledge and understanding of industry; to develop skills further to teach specific subject; and to develop professionally and personally. Examples of industries used include: Deeside Power; Mc Donald's; RSPB; Airbus UK; Venue Cymru; Welsh Water; Welsh Mountain Zoo; and the Slate Museum.</p> <p>The presentation then considered RE-specific placements, which supported the new national framework for religious education for 3 to 19 year olds in Wales with its emphasis on learning across the curriculum, including 'careers and the world of work'. A number of practical examples of placements were described which covered the Liverpool Faith Trail and the multi-faith centre at Ysbyty Gwynedd, Bangor.</p> <p>Relevant themes for RE placements include exploring equality and diversity in the workplace, fair trade, volunteering, and work involving the natural world. Pertinent examples of these themes</p>
