***Re: Cuts to grants 2014-15***

I attach letters from the Minister for Education and Skills, Huw Lewis, which refer to the call on him to cut the expenditure of his department *during this year (2014-15)*. He notes in the letters that he is seeking an overall reduction of up to £5m from the grants to schools budgets.

At this moment, the details of the cuts to different school grants are not known, and therefore we are not in a position to know how the cuts will affect the Consortium, Gwynedd or individual schools. However, it is inevitable that the cuts will affect our schools. In spite of our commitment to try and protect schools, these cuts could affect the money which is already in your budgets, including SEG money.

During the forthcoming weeks Gwynedd Education Authority will be in discussion with the Consortium and Welsh Government to try and find the best way in which to achieve these reductions during the year.

It must be noted that these cuts are Welsh Government steps and they are nothing to do with the Council. I can note that the Council has no intention of asking for in-year reductions to your core budgets.

When more information is available, I will contact you further.
