Item 7: FUTURE OF EDUCATION PROVISION IN THE BALA CATCHMENT AREA

#### DECISION

To consult with the governing bodies of the schools of the Berwyn Catchment-area on the option to abandon the proposal to establish a Voluntary Controlled 3-19 Learning Campus (VC, Church in Wales) in the town of Bala, in accordance with section 55 (5) of the Schools Standards and Organisation Act 2013 - with the intention to return to the Cabinet to report on the outcome of the consultation and make recommendations on the way forward.

#### REASONS FOR THE DECISION

Following correspondence from the solicitors of the Diocese of St Asaph a report was submitted to the Cabinet on 13 December 2016 recommending the option to abandon the proposal to establish a Voluntary Controlled 3-19 Learning Campus (VC, Church in Wales) in the town of Bala, in accordance with section 55 (5) of the 2013 Schools Standards and Organisation Act 2013. It was resolved to defer the decision in order to consider legal opinion on the Diocese's latest stance and to give officers the opportunity to discuss with the catchment-area's governors.

Following the deferral, information and correspondence was received from the governors of some of the schools stating their unwillingness to be involved with the proposal for a Voluntary Controlled School. There was also evidence that opposition to the proposed designation has significantly increased in the area. This was considered to represent circumstances that led to the need to reconsider implementing the original proposal on the grounds noted in section 55(5).

In accordance with the requirements of the Schools Organisation Code 2013 a formal consultation must be held with the governing bodies of the affected schools before deciding to implement Section 55(5).

- III. To commit to receiving grant resources to undertake the pilot (outline amount available from the Government to Gwynedd and Anglesey is £1,869,719 but to be amended according to the number of children participating in the pilot).
- IV. To agree to establish a Gwynedd and Anglesey Childcare Unit for 2017-18.

### **REASONS FOR THE DECISION**

The Government acknowledges that childcare is one of the greatest challenges facing working families in Wales and developing a better childcare offer is considered a priority for the Government. The Government has committed to providing 30 hours per week of early years education and free childcare for working parents of three to four year olds, for 48 weeks a year.

Following discussions with the Government, it was noted that Gwynedd and Anglesey needed to target 1200 children during 17-18. Gwynedd will be targeting 62% of this figure. The numbers have increased since writing the report and as a result of this growth in numbers, the sum of money will also change.
