Item 7: APPLICATION FOR EUROPEAN FUNDS TO IMPROVE INFRASTRUCTURE AND ACCESS AT SNOWDONIA AREOSPACE CENTRE, LLANBEDR

DECISION

Resolved to

1. Support the principle that Gwynedd Council takes the role of the Leading Body for the project
 2. Subject to receiving a confirmation of the other contributions:
 - i. That the Cabinet gives its approval to the Economy and Community Department's decision to commit £250,000 of its Joint Funding Fund towards a plan of approximately £25,000,000 to develop appropriate infrastructure to support the development of the Snowdonia Aerospace Centre in Llanbedr.
 - ii. That Gwynedd Council commits another £250,000 to the plan in advance of the proposed Asset Management Plan.

REASONS FOR THE DECISION

Developing the Snowdonia Aerospace Centre, Llanbedr to be an excellence centre for developing and trialling remotely-piloted vehicles could lead to the creation of 100 jobs. To enable the development of the site, further investment is needed to develop the appropriate infrastructure for the site, including improvements to the facilities on the airfield and a new access road which by-passes Llanbedr village centre.

The plan's total cost will be approximately £25,000,000 including funding from the private sector, Welsh and European Government. The Council is required to commit £500,000 to jointly fund the plan, subject to receiving confirmation of the other contributions.
