#### DECISION

Resolved to:

- i. Approve the proposal for the closure of Ysgol Bro Tegid, Ysgol Beuno Sant and Ysgol y Berwyn on 31 August 2019 and for the Welsh Medium 3-19 Learning Campus, community status, to be established on the existing site of Ysgol y Berwyn to open on 1 September 2019.
- ii. To approve publishing statutory notices on the proposal in (i) above in accordance with the requirements of Section 48 of the School Standards and Organisation (Wales) Act 2013.

## **REASONS FOR THE DECISION**

The Cabinet agreed on 24 October 2017 to conduct a statutory consultation in accordance with the requirements of Section 48 School Standards and Organisation (Wales) Act 2013, in the Berwyn catchment area on the favoured model, namely the proposal to close the schools of Beuno Sant, Bro Tegid and Ysgol y Berwyn and establish a 3-19 Welsh Medium Learning Campus, with community status on the existing Ysgol y Berwyn site to be implemented from September 2019. Generally strong support was expressed through the consultation to the proposal of establishing a 3-19 Learning Campus in Bala. The next step in implementing the proposal will be to publish a statutory notice for the closure of Ysgol Bro Tegid, Ysgol Beuno Sant and Ysgol y Berwyn on 31 August 2019, and for the Welsh Medium, community status, 3-19 Learning Campus to be established on the existing site of Ysgol y Berwyn to open on 1 September 2019.

Due to the financial pressure on the Council, and the need to make substantial savings, it was noted that it would be possible to satisfy the need in a different way by transferring the Senior Learning Manager from the Economy and Community Service to the Children and Supporting Families Service. The Chief Executive wanted to seek the Cabinet's opinion on his intention to implement this change before going forward.

Item 10: 2018/19 BUDGET AND 2018/19 - 2020/21 FINANCIAL STRATEGY

#### DECISION

To recommend that the Council (at its meeting on 1 March 2018):

- i. Establish a budget of £242,862,930 for 2018/19, to be funded by £175,127,330 of Government Grant and £67,735,600 Council Tax income, with an increase of 4.8%.
- ii. Establish a capital programme of £8.389 in 2018/19 to be funded by sources noted in clause 9.4 of the report.

To note the Medium Term Financial Plan in Section B, and adopt the strategy which is in part 32-34 of the Plan.

#### REASONS FOR THE DECISION

The Council needs to set a budget for the 2018/19 financial year and determine the Council Tax level. The Cabinet will be recommending these to the Full Council for a decision.

The strategy attempts to protect the services provided to the people of Gwynedd and recommends an increase in the Council Tax to achieve this objective this year. Whilst ensuring savings, it is intended to achieve them in those areas that would have least impact on our people.
