Authorise the Leader to commit the Council to Heads of Terms with the Governments alongside the political and professional leaders from the nine other statutory partners represented on the North Wales Economic Ambition Board, and the North Wales Mersey Dee Business Council, with the Proposition Document forming the boundaries for the Heads of Terms agreement.

REASONS FOR THE DECISION

In September 2018, the Cabinet confirmed its support for the Joint-committee model for the Growth Deal. Additionally, the Leader was authorised to represent the Council on the 'Shadow Joint-Committee' during the interim period. In July this year, the Cabinet and the Council adopted the Governance Agreement for the planning and development stages of the Growth Deal.

The Proposition Document, received at the Cabinet, identifies the programmes and projects that both Governments are considering for inclusion in a Growth deal, at the Heads of Terms stage. The region and deal are now about to reach Heads of Terms. The regional Partners are asked to confirm the Proposition Document in order to give a mandate to their leaders to commit to a Heads of Terms Agreements which, following this, will be the starting point for the final stage of developing the Bid and negotiating with the Governments.
