SUBJECT Item 6: FLYING START, CHILDCARE AND EARLY YEARS PROGRAMMES		
DECISION A grant had been received to expand the Flying Start Programme in the county. Rights had been delegated to the Head of Children and Supporting Families in consultation with the Head of Finance to prepare and submit business cases to the Government for individual grants from the Childcare and Early Years Capital Programme and accept proposals on behalf of the Council.		
REASONS FOR THE DECISION Cabinet approval was needed to the direction to extend the childcare element of the Flying Start Programme in the County, and to submit business cases to the Government to attract capital funding to achieve this extension and to expand the broader childcare provision in the County.
