REASONS FOR THE DECISION

Since 2015 Welsh Government has commenced a cycle of significant change to achieve a new Curriculum for Wales. To be successful, Welsh Government acknowledges it is crucial that all aspects of the school system are aligned with and support the Curriculum for Wales along with its underlying principles.

In June 2022, Welsh Government published new information and guidance on school improvement and the new framework for evaluation, improvement and accountability. This guidance is relevant to schools, pupil referral units (PRUs), Local Authorities, diocesan authorities, regional consortia and Estyn, and outlines the expectations of them in contributing to sustainable school improvement. Therefore, all stakeholders within the education system in Wales will need to adhere to this new School Improvement Framework for evaluation, improvement and accountability.

GwE needs to be able to evaluate and clearly capture the impact of its work in line with its core duty of school improvement, and so that it may fully meet the expectations set out in the School Improvement Guidance.
