Item 6: YSGOL FELINWNDA

DECISION

- a. To approve finally the proposal under Section 43 of the School Standards and Organisation (Wales) Act 2013, given through a statutory notice, to close Ysgol Felinwnda on 31 December 2023, and to transfer the current pupils to an alternative school nearby, either Ysgol Bontnewydd or Ysgol Llandwrog, according to parents' choice, from 1 January 2024.
- b. To approve transport arrangements for the transition phase only, where free transport would be provided for those learners who are currently registered in Ysgol Felinwnda and living in the catchment area of Ysgol Felinwnda, to Ysgol Bontnewydd or Ysgol Llandwrog, for the remainder of the learner's time in either of those schools, in accordance with Cyngor Gwynedd's transport policy.
- c. To consult on the future of Ysgol Felinwnda's current catchment area to agree which school, or schools, will serve as a future catchment school for the children of Ysgol Felinwnda's current catchment area.

REASONS FOR THE DECISION

Based on the PLASC (Pupil Level Annual School Census) January 2023, Ysgol Felinwnda is the school with the lowest number of learners in the county, with a total of 8 learners. Consequently, the Education Department submitted a report to the Cabinet on 11 July 2023 requesting permission to hold a statutory objection period on the proposal to close Ysgol Felinwnda in accordance with the School Standards and Organisation (Wales) Act 2013 and the statutory Welsh Government Code (School Organisation Code 011/2018).

Section 48(3) of the 2013 Act provides that the requirement to consult does not apply to proposals to close a 'small school' as defined in the Act, and the School Organisation Code 011/2018 provides as follows:

"Where a school has fewer than 10 registered pupils (or there are no pupils

remaining at a school) at the January census point, the 2013 Act permits governing bodies/local authorities to undertake a streamlined procedure to bring about official closure of the school.

The only thing they would be required to do under that procedure would issue the notice of closure – the requirement for general consultation would be waived, provided sufficient equivalent school places have been identified which would be reasonably accessible to those pupils actually or potentially displaced."

Since there are only 8 registered learners at Ysgol Felinwnda in the January 2023 PLASC, the School Organisation Code allows the authority to follow a streamlined procedure to close the school. Specifically, the requirement for general consultation is waived. In accordance with the requirements of the School Organisation Code, the authority was only required to publish a statutory notice and undertake the normal objection period, and to then consider any objections received before reaching a final decision.

Following the submission of a report to the Cabinet on 11 July they:

- Approved the commencement of the process to close Ysgol Felinwnda on 31 December 2023 under Section 43 of the School Standards and Organisation (Wales) Act 2013.
- ii. Approved the issuing of a statutory notice, on the proposal to close Ysgol Felinwnda on 31 December 2023, allowing a statutory objection period of 28 days in accordance with the requirements of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code 011/2018, and to transfer the current learners to an alternative school nearby, namely Ysgol Bontnewydd or Ysgol Llandwrog according to parents' choice, from 1 January 2024.
- iii. Approved transport arrangements for the transition phase only, where free transport would be provided for those learners who are currently registered in Ysgol Felinwnda and living in the catchment area of Ysgol Felinwnda, to Ysgol Bontnewydd or Ysgol Llandwrog, for the remainder of the learner's time in either of those schools, in accordance with Cyngor Gwynedd's transport policy.
- iv. Subject to the Cabinet's decision regarding the proposal to close Ysgol Felinwnda, to allow a consultation to be held on revising the catchment area boundaries of schools that border Ysgol Felinwnda's current catchment area.

Item 7: LOCAL GOVERNMENT AND ELECTIONS (WALES) ACT 2021 – PANEL PERFORMANCE ASSESSMENT

DECISION

They agreed on the timetable for holding a Panel Performance Assessment during the autumn term of 2024, and to commission the Welsh Local Government Association to support the work.

REASONS FOR THE DECISION

The Local Government and Elections (Wales) Act 2021 places a duty on Councils to conduct a Panel Performance Assessment once in every electoral cycle. The duty came into force in May 2022.

It is noted that the Council is free to determine who should carry out and coordinate the panel assessment and to determine its timing, therefore guidance is required on this. Three statutory duties must be followed when carrying out a panel assessment:

- Preparation (determine the scope, terms of reference, membership etc.)
- Assessment (carry out the assessment, present findings)
- Follow-up (draw up the final report, the Council's response)

After the Full Council adopted changes to the Constitution in relation to the Panel Performance Assessment on 28 September 2023, the function to arrange and appoint a panel was allocated to the Cabinet but the response to the report and the recommendations would be retained for the Full Council.

Conducting the assessment by commissioning an external body to do the work is likely to cost up to £25k.

Item 10: SAVINGS OVERVIEW: PROGRESS REPORT ON REALISING SAVINGS SCHEMES

DECISION

- 1. To accept the information in the report and note the progress towards realising the savings schemes for 2023/24 and previous years.
- 2. It was acknowledged that the situation had now changed so much that historical savings schemes totalling £2,056,430 could not be achieved, and they were removed from the budget.
- 3. To use the £1,956,430 savings provision to fund the removal of savings schemes, together with using a £100,000 Council Tax premium for the savings scheme relating to Homelessness.

REASONS FOR THE DECISION

In the '2023/24 Budget' report to the Full Council on 2 March 2023, it was reported that savings worth £5,194,220 were required for the 2023/24 financial year in order to close the 2023/24 financial deficit. The savings are a combination of £950,250 that had been approved in previous years, together with new savings of £1,146,600 for Schools and £3,097,370 for the rest of the Council.

In addition, by reviewing the Council's policy on debt repayment that finances capital expenditure (Minimum Revenue Provision), as set out in the report to the Full Council on 2 March 2023, a further £2,400,000 was added to the 2023/24 savings schemes.
