REASONS FOR THE DECISION

The asset plan is essential for being able to provide services to the people of Gwynedd. The costs of using our assets on a day-to-day basis come under the Council's revenue expenditure, while costs to renew, upgrade and provide new assets are capital expenditure. The Asset Management Plan is the long-term strategy in order to plan ahead to prioritise capital expenditure enabling us to manage our essential assets and avoid the risk of failing to provide services.

The current Asset Management Plan was adopted in 2019 and reviewed in 2021.

Although five years remains of our current Asset Management Plan, it is good practice to have a 10-year plan for multiple reasons:

- a) Capital expenditure requires time to plan in advance
- b) Departments need assurance if they will have the capital to manage risks
- c) Opportunities to apply for grants need to know if we have match funding

d) The capital situation is constantly changing - inflation has had an impact which means we cannot achieve as much, as well as less money available

e) Departments' requirements change over time - much has changed since 2019.

The conclusion of all this is that we need a current Asset Management Plan in order to respond to the risks and needs that are alive today and for the next few years
