Therefore, this function is separate from the Council's position as statutory public authority and subject to the specific requirements and responsibilities of charity management. There is public interest in obtaining information about how the Council operates in such a function. However, this is addressed via charity law, this report is regarding business transactions and options the trustees should have an appropriate opportunity to discuss and evaluate in a free and open manner before reaching the best conclusion for the charity's benefit. Conducting the discussion publicly would undermine their ability to achieve this. The Cabinet sitting as trustees is the only appropriate forum to implement this. Therefore, the public interest falls in favour of exemption.

#### 6. THE LLOYD GEORGE MUSEUM CHARITABLE TRUST

The report was presented by the Assistant Head of Culture in the Economy and Community Department.
