#### **Background**

- 1. I attach a copy of the application form of Councillor Morwenna Pugh of Ffestiniog Town Council.
- 2. The Standards Committee is entitled to allow dispensation if the situation falls within one (or more) of the situations listed below:
  - " (a) no fewer than half of the members of the relevant authority or of a committee of the authority (as the case may be) by which the business is to be considered has an interest which relates to that business;
  - (b) no fewer than half of the members of a leader and cabinet executive of the relevant authority by which the business is to be considered has an interest which relates to that business and either paragraph (d) or (e) also applies;
  - (c) in the case of a county or county borough council, the inability of the member to participate would upset the political balance of the relevant authority or of the committee of the authority by which the business is to be considered to such an extent that the outcome would be likely to be affected;
  - (d) the nature of the member's interest is such that the member's participation in the business to which the interest relates would not damage public confidence in the conduct of the relevant authority's business;
  - (e) the interest is common to the member and a significant proportion of the general public;
  - (f) the participation of the member in the business to which the interest relates is justified by the member's particular role or expertise;

- (g) the business to which the interest relates is to be considered by an overview and scrutiny committee of the relevant authority and the member's interest is not a pecuniary interest;
- (h) the business which is to be considered relates to the finances or property of a voluntary organisation of whose management committee or board the member is a member otherwise than as a representative of the relevant authority and the member has no other interest in that business provided that any dispensation shall not extend to participation in any vote with respect to that business; or
- (i) it appears to the committee to be in the interests of the inhabitants of the area of the relevant authority that the disability should be removed provided that written notification of the grant of the dispensation is given to the National Assembly for Wales within seven days in such manner as it may specify."

('The Standards Committees (Grant of Dispensations) (Wales) Regulations 2001)

The current application has been made on the basis of paragraph (f).

#### Background

4. In accordance with the Committee's procedures background information was sought from the clerk to the council. The matter that will be before the Town Council is consideration of whether it wishes to accept Barnarados' proposal to transfer the building into council ownership. Barnado's are the owners and operated from one part of the building while the other part is let to the 'O Law i Law' nursery. The Clerk has confirmed that the matter is now public knowledge and is no longer confidential as is noted in the application form, and has provided the following written information as background:

"An official from Barnado's contacted the Town Council to discuss the future of the Caban Bach building in Blaenau Ffestiniog. Barnado's wishes to leave the building, but wants to ensure that the building stays "in the community" and is therefore looking for a public body to take over, rather than selling it on the open market and the building going into private hands. The Council therefore wants to consider the possibility of doing this. Although Councillor Morwenna Pugh has no interest in the building itself, she has a personal and prejudicial interest. The Councillor has explained the relationship in her application for a dispensation."

5. I have also contacted the applicant to inform her of her right to attend the meeting in order to be able to answer any questions the Committee may have, but she has confirmed that she will, unfortunately, not be able to attend

- 6. The Ombudsman's guidelines on the Code of Conduct note the following in relation to dispensations in general:
  - "3.51 Only the Standards Committee can grant the dispensation and will do so at its discretion. The Standards Committee will need to balance the public interest in preventing members with prejudicial interests from taking part in decisions, against the public interest in decisions being taken by a reasonably representative group of members of the Council. ..."

#### Summary

7. The existence of a prejudicial personal interest is impicit in a request for a dispensation, and therefore the committee does not need to decide on that point. In reaching a decision the Committee is required to balance the factors outlined in the Ombudsman's guidance above.

The Committee may decide to:

- a. Grant a dispensation,
- b. Grant a partial dispensation, or
- c. Refuse the application

#### **Guidance Notes**

1. This is the form for submitting an application for a dispensation, i.e. permission to take part in a discussion even though you have a 'prejudicial interest' under the Code of Conduct. Further information regarding interests can be found in the Code of Conduct itself, the Ombudsman's Guidance and the Gwynedd Council 'Interests' leaflet.

#### 2. Circumstances in which dispensations may be granted

The Standards Committee may grant a dispensation if the application comes within one or more of the circumstances listed in *The Standards Committees (Grant of Dispensations) (Wales) Regulations 2001):* 

- "(a) no fewer than half of the members of the relevant authority or of a committee of the authority (as the case may be) by which the business is to be considered has an interest which relates to that business;
- (b) no fewer than half of the members of a leader and cabinet executive of the relevant authority by which the business is to be considered has an interest which relates to that business and either paragraph (d) or (e) also applies;
- (c) in the case of a county or county borough council, the inability of the member to participate would upset the political balance of the relevant authority or of the committee of the authority by which the business is to be considered to such an extent that the outcome would be likely to be affected;
