1. Introduction

- 1.1 There is considerable history to the Local Government and Elections (Wales) Act 2021, which stems from the Local Government (Wales) Bill introduced by the former Local Government Minister Leighton Andrews in 2015. Since then, there have been several changes and developments to the aim and emphasis of the Legislation. The main change is a step back from an Act, which focused, on reorganising Councils be that voluntarily or through statute. You may recall the consultations that were considered along the way.
- 1.2 By now, although there are provisions in the Act that create a framework for merging councils, they do not represent the main aim of the provision. There is now Legislation on the table that introduces a number of changes and powers in relation to the governance of Local Government in Wales. This is not to say that there are elements of the Act that are not far reaching; this is especially true in the area of Local Government franchise, Collaboration and Performance Management. The Council was provided with a report in March and asked that the Committee maintain and overview of the implementation of the Act.

2. The Act

- 2.1 The Act received Royal Assent on 20 January 2021. It has nine main parts that relate to Principal Councils Town and Community Councils and other Authorities. There are some provisions that are already in force but await the publication of relevant regulations or guidance.
 - PART 1 ELECTIONS
 - PART 2 GENERAL POWER OF COMPETENCE FOR LOCAL AUTHORITIES
 - PART 3 PROMOTING ACCESS TO LOCAL GOVERNMENT
 - PART 4 LOCAL AUTHORITY EXECUTIVES, MEMBERS, OFFICERS AND COMMITTEES
 - PART 5 COLLABORATIVE WORKING BY PRINCIPAL COUNCILS
 - PART 6 PERFORMANCE AND GOVERNANCE OF PRINCIPAL COUNCILS
 - PART 7 MERGERS AND RESTRUCTURING OF PRINCIPAL AREAS
 - PART 8 LOCAL GOVERNMENT FINANCE
 - PART 9 MISCELLANIOUS

3. Risks

The Act has already been placed in the Corporate Risk Register because of its significance. However, some aspects will need more detailed consideration in particular Corporate Joint Committees:

Development work needs to be undertaken on the model and further regulations are expected which will provide more detail on interrelationship between these bodies and the Councils. Consideration needs to be given to;

- the interrelationship between the Councils and the CJC
- the role will Local Authority Scrutiny have in their governance
- the implications for the North Wales Economic Ambition Board and the Growth Deal.

Following the Committee's approval of the proposed Work Programme it is intended that a report is presented to the Corporate Governance Group in relation to the risks with a view to focusing on the issues and responses.

4. The Next Steps

The proposed Work Programme is set out in Appendix 1. The range of provisions in the Act means that a series of reports will be submitted as appropriate to the Council, Cabinet and relevant Committees. Elements of the work are already underway. The timetable for these provisions to come into force, and their diverse range, leads to this type of process. An officer-working group has started on this work.

To approve the Work Programme and to request an update for the Committee's October meeting.
