## **1. APPLICATION RECEIVED**

- 1.1 An application is attached for a premises licence for Canolfan y Fron, Llandwrog, Caernarfon, LL54 7BB. The applicant (limited company) is seeking a premises licence for a community hub to hire rooms, café, village shop, tourist accommodation, changing areas and car charging points.
- 1.2 The application is made in relation to film showings, plays, indoor sports, boxing or wrestling entertainment, live and recorded music, dance performances and the sale of alcohol.
- 1.3 Officers from the Licensing Authority are satisfied that there is sufficient evidence that the application has been submitted in accordance with the requirements of the Licensing Act 2003, and the relevant regulations and is therefore valid.
- 1.4 Several objections to the application have been received from nearby residents, including members of the residents association. Police and the Fire and Rescue Service had no observations or objections.
- 1.5 It is suggested that the Sub-committee should ask the applicant to elaborate on the application, in terms of the late hours use requested; particularly in relation to using the area outside the centre for licensed activities such as the supply of alcohol and for staging entertainment.

**2. Measures recommended by the applicant to promote the licensing objectives**

The measures recommended by the applicant include the following -

- A Caretaker is employed to look after the Centre therefore any problems will be reported immediately
- A CCTV system is in operation
- Staff training on the sale of alcohol and implementing a proof of age scheme
- Respectful use of external areas
- Fire protection system and alarms have been installed with an appropriate supply of first aid equipment

**3.2 Members of the public and neighbouring residents**

Six e-mails were received objecting to the application based on the four licensing objectives of:

- Prevention of public nuisance
- Public safety
- Prevention of crime and disorder
- Protection of children from harm

Concerns were expressed regarding anti-social matters in terms of noise, public nuisance, sanitary issues, parking and crime and disorder. It was noted mainly that the Ganolfan committee had not sought a public consultation beforehand, and the applicant's proposed hours raised concern.

A petition of 36 signatories had been signed by y Fron residents association stating the conditions and times that would be acceptable.

4 RECOMMENDATION

It is recommended that this Committee carefully considers the concerns of nearby residents and approves the application in accordance with the requirements of the Licensing Act 2003.
