See additional notes and plan.</p> <p>Shopfloor area with product – no DVDs or Magazines will be sold.</p> <p>Boutique style branding and design – not seedy/tacky. No “sex shop” signs etc.</p> <p>Private offices on first floor to run the online side of the business.</p> <p>Nobody under the age of 18 will be allowed inside under any circumstances and ID will be required if we believe they are under this age.</p> <p>We will also be using Challenge 25 to ensure we are not selling to those under 18.</p> <p>CCTV will be present on entrance door on the street, giving staff advance notice of people entering the store, giving us the ability to age check before entry.</p> <p>Counter will be just inside door again allowing staff to monitor customer’s ages as they enter.</p> <p>Branding – Shop will be called Eva Amour with the tagline Love Life – not offensive or vulgar, upmarket, boutique sounding, minimalistic, stylish and modern.</p> <p>Store will be a place for customers to also discuss sexual and mental health (we aim to promote this and hope to run events/ workshops based around these matters).</p>
