

# Stage 1 Results: The responses of Community/Town Councils, groups and organisations in the Llŷn Area



**Draft Summary (January 2022)**

## 1. Introduction

- 1.1 The purpose of the 'Ardal Ni 2035' project is to conduct a conversation and discussion with local communities to identify what matters to residents and how they would like to see the area develop in the next 10-15 years.
- 1.2 We intend to collaborate and jointly develop solutions with organisations, groups and individuals. At the end of the project there will be 13 specific regeneration frameworks that reflect the aspirations of local communities.
- 1.3 The first stage of the project was to conduct initial talks with Councillors, Community and Town Councils and local regeneration groups in order to establish:
  - What is good about the area?
  - What is not so good about the area?
  - What changes would you like to see happen in your area in the next 15 years, that would make your area a better place to live?
- 1.4 An invitation, together with area statements (namely booklets that summarised the main economic, social, cultural and environmental data) were sent to all Councillors, Community Councils and the main local groups.
- 1.5 Between September and November 2021 a discussion took place with **17** Community / Town Councils, organisations, groups, Local Members and individuals in the LIŷn Area
- 1.6 Initial discussions have been held with young people in the area via the youth service. There is a summary of the responses to the questions in **appendix 3**.

### 5.2 Are you aware of any local consultation work that has been undertaken in the last year?

This is a list of the consultation work noted in response to this question in the Llŷn Area:

- Survey of the intentions and understanding of Llŷn residents of electric vehicles and charging from Ynni Llŷn, Canolfan Fenter Congl Meinciau and SPEN [Scottish Power Energy Network].
- Eco-museum [Llŷn Landscape Project Officer]

- Participatory evaluation work, Communities First Pen Llŷn
- Consultation on the development of Penrhos homes for older people
- Ysgol Abersoch Consultation
- Holiday homes / Council tax premium consultation
- A Rural Housing Facilitator is currently undertaking a survey on behalf of the Grŵp Cynefin Housing Association to ascertain what is the housing need in the area.
- Plas Carmel Project engagement activities during the last 2-3 years.
- Many people turned up to Hawl i Fyw Adra (The Right to Live at Home) protests showing support and that there is a lot calling on the Council to take action in terms of the housing crisis.
- Yr Heliwr asked for local people's opinions on services in the public house. Yr Heliwr in the process of establishing a community garden in Cae Iorwerth, Nefyn; the name of the scheme is 'hwb i'r hinsawdd' (climate action boost)
- Second Homes Report by Simon Brooks.
- Cwmni Frân Wen has recently worked with young people in Nefyn.
- Nefyn Town Council have been in discussion with Welsh Government.
- Farm produce project with the Old Mill in Aberdaron e.g. farmers producing corn and milling it locally to produce flour.

### **5.3 Other issues relating to the 'Ardal Ni 2035' work that arose in the Llŷn Area;**

- Concern about the accuracy of the statistics presented; one caused major concern and gives a complete misconception of the area, namely these statistics about the Environment - Pen Llŷn 55.1%, Gwynedd 76.6%, Wales 77%. \*namely the lowest in Gwynedd
- Statistics are misleading and people who have moved to the area are also part of the statistics. A report published by Wales Rural Observatory on Deep Rural Areas indicates that salaries could be as low as £5,000.
