

# Stage 1 Results: The responses of Town/Community Councils, groups and organisations in the Pwllheli Catchment Area



**Draft Summary (January 2022)**

## 1. Introduction

- 1.1 The purpose of the 'Ardal Ni 2035' project is to conduct a conversation and discussion with local communities to identify what matters to residents and how they would like to see the area develop in the next 10-15 years.
- 1.2 We intend to collaborate and jointly develop solutions with organisations, groups and individuals. At the end of the project there will be 13 specific regeneration frameworks that reflect the aspirations of local communities.
- 1.3 The first stage of the project was to conduct initial talks with Councillors, Community and Town Councils and local regeneration groups in order to establish:
  - What is good about the area?
  - What is not so good about the area?
  - What changes would you like to see happen in your area in the next 15 years, that would make your area a better place to live?
- 1.4 An invitation, together with area statements (namely booklets that summarised the main economic, social, cultural and environmental data) were sent to all Councillors, Community Councils and the main local groups.
- 1.5 Between September and November 2021 a discussion took place with **14** Town / Community Councils, organisations, groups, Local Members and individuals in the Pwllheli catchment area.
- 1.6 Initial discussions have been held with young people in the area via the youth service. There is a summary of the responses to the questions in **appendix 3**.

### 5.2 Are you aware of any local consultation work that has been undertaken in the last year?

- The Lloyd George Museum has been undertaking engagement activities over the last two years.
- Engagement work that is specific to Menter y Plu plans.
- Some discussion, albeit ineffective, between the Town Council and Gwynedd Council regarding establishing and developing the Nature Reserve.
- Hafod Ceiri Engagement Activities
- Playing Field Committee engagement activities.
- Antur Aelhaearn community gym questionnaire.
- The Council held a motorhomes consultation.
- Pistyll Community Council looked at a car park.

- Town and community councils operating on behalf of the community, e.g. creating a petition to demonstrate the extent of the demand in the community for a footpath between Chwilog and Afonwen.
- Research by Richard Parry Hughes in the last 2-3 years on the impact of land planning over the last 50 years on Pen Llŷn.
- Seimon Brooks' report on second homes was recent work commissioned by Welsh Government.

**5.3 Other issues relating to the 'Ardal Ni 2035' work that arose in the Pwllheli Catchment Area:**

- Important to ask the town's young people and families about their vision for 2035 - holding meetings to seek opinion would be a good idea.
