### **APPLICATION**

An application to vary the premises licence of University Plaiice, 21 Holyhead Road, Bangor made by Mr Mehmet Ali Usal, was received by the licensing authority on 8 December 2015.

The premises is located among a row of businesses and shops in Upper Bangor and provides late night refreshments for consumption off the premises. The nature of the proposed variation is to extend the opening hours and hours for providing late night refreshments on Monday, Tuesday, Wednesday and Sunday until 3:00 am.

### **BACKGROUND INFORMATION**

The applicant has previously submitted applications to extend the licensable hours of the premise. These applications were decided by the sub-committee. In October 2013, they were granted an application to extend the opening hours on Friday and Saturday night until 3:30 am. In September 2014, they were granted an application to extend the opening hours on a Thursday until 3:00 am.
