### **Results of the Public Consultation - Summary**

The consultation questionnaire was live on the Cyngor Gwynedd website from 8 December 2022 to 3 January 2023.

A total of 643 responses were received to the questionnaire, all received on-line. The following table shows the number of respondents per area in Arfon, Dwyfor and Meirionnydd.

#### **Priority Fields**:

The results show that the respondents **agree with all priority fields**, but fewer (66.9%, N=430) respondents agreed with priority field 5 which was to ensure that our residents can continue to live in naturally Welsh-speaking communities, compared with all other priority fields.

#### Differences between the areas of Arfon, Dwyfor and Meirionnydd:

There are differences in the views of respondents according to where they live. The biggest difference is that a higher percentage of respondents living in Arfon (75.5%, N=213) **agree** with priority field 5 compared with respondents living in Dwyfor (62.0%, N=85) and Meirionnydd (60.1%, N=122). The biggest difference is that a higher percentage of the respondents living in Dwyfor (16.8%, N=23) **disagree** with priority field 5 compared with respondents living in Arfon (8.2%, N=23) and Meirionnydd (14.8%, N=30).


#### **Observations:**










