1. DECISION

The Council is asked to:

Adopt Option 1 – which is to adhere to the current scrutiny committee arrangements and approve the actions to improve efficiency contained in Appendix 2.

2. BACKGROUND AND RATIONALE

Review

2.1 A promise was made to review the committees' workload following the Full Council's decision in June 2022 to place corporate matters within the Education and Economy Scrutiny Committee. It was decided that it would be sensible to review the workload of the various committees at the same time as considering the amendments to our scrutiny arrangements following receiving the Audit Wales report.

June 2022 decision

- 2.2 Following the requirements of the Local Government and Elections (Wales) Act 2021, it became clear that it was not possible for the Governance and Audit Committee to continue scrutinising corporate matters. It was decided to place the corporate matters as a responsibility of the Education and Economy Scrutiny Committee and recommended reviewing the arrangements after matters stabilised following around 18 months.
- 2.3 The current terms of reference of the scrutiny committees following the Full Council's decision in June 2022, is seen in **Appendix 1**. The document highlights the changes needed to reflect the Communities Scrutiny Committee's field of work following recent changes. Subject to the decision the Monitoring Officer will report separately on constitutional changes.

Audit Wales

2.3 Audit Wales held an independent review of scrutiny efficiency in Cyngor Gwynedd during the first few months of 2023 and submitted its final report at the end of September 2023. It was an encouraging report with 6 recommendations – actions have already been reported to the Governance and Audit Committee. Please see **Appendix 2**.

Consultation

2.4 An opportunity was given to Members and officers to provide input to the review. Two workshops were held for Councillors on 20/10/2023 and 10/11/2023. 23 Members attended. Councillors were given the opportunity to express their views on the most suitable location to scrutinise corporate matters along with other matters relating to scrutiny.

The most appropriate location to scrutinise corporate matters

- 2.5 Below are the messages arising from the workshops when discussing the most appropriate location to scrutinise corporate matters:
 - There was no clear direction arising from the workshops regarding the 'home' of corporate matters
 - There was no clear direction to the scrutiny arrangements for the future
 - There was a general sense that the Education and Economy Scrutiny Committee's workload was too heavy and that either corporate matters and/or economy matters could be moved to another committee.
 - Observations were given that the Communities Scrutiny Committee was the most appropriate location for these elements
 - It was added that an additional committee could be created (a fourth committee for those matters economy and corporate) and leaving the education matters in their own scrutiny committee
 - Not everyone agreed with this and the data up until now in terms of the number of items scrutinised does not support additional pressure on one committee.
 - One member asked for one principal scrutiny committee and more investigations
 - Some called for 4 (or 5) scrutiny committees and more investigations
 - Some noted that the current arrangements were correct and that past experience indicated that there were not enough matters to hold another committee over the Council period.

Possible options

- 2.6 As a result of the above comments the options below were formed. It is noted that the matters noted would be implemented following Audit Wales' review for any option.
- 2.7 The options:

Option 1 - no change to the current arrangements

Journey to a decision

2.8 The information and possible options were presented to the following meetings asking them to consider the options and the pros and cons of each.

- 2.9 Note below the basis of the Scrutiny Forum's conclusions:
 - A positive report was received from Audit Wales, and getting to grips with the action plans will build on the success of the current arrangements and strengthen them, by further improving scrutiny efficiency
 - Good progress has already been made with our scrutiny arrangements, and implementing some of the steps have already been seen, such as sharpening the recommendations by the committees and the development of the cabinet's forward programme.
 - Experience has shown that work programmes stabilise over a period of five years
 - While prioritising matters can be challenging, it enables scrutiny on a cross-section of matters and avoids excessive scrutiny on one subject that could be of specific interest to individuals
 - Developing the arrangements for the Area Forums/briefing sessions and presenting information will allow Members to get detailed information about their area in a specific way, by enabling the Scrutiny Committees to scrutinise strategically on specific matters
- 2.10 A report based on the conclusions of the Scrutiny Forum was submitted to the Governance and Audit Committee on 18/01/24 for them to approve that the review arrangements had been completed properly. The Committee decided to recommend that the Full Council approve Option 1 subject to work being carried out to improve the efficiency and operations of the Scrutiny Committees.

2.11 As noted already in the report, it is intended to get to grips with the actions in response to the Audit Wales recommendations in order to build on the success of the current arrangements and strengthen them, by further improving scrutiny efficiency. The actions are believed to address the clause in the Governance and Audit Committee's recommendation that work be carried out to improve the efficiency and operations of the Scrutiny Committees.

Well-Being of Future Generations (Wales) Act 2015

2.12 The Well-Being of Future Generations (Wales) Act 2015 is about improving the social, economic, environmental and cultural well-being of Wales. The Act places a 'well-being duty' on public bodies aimed at achieving 7 national well-being goals for Wales - a Wales that is prosperous, resilient, healthier, more equal, has cohesive communities, a vibrant culture and thriving Welsh language and is globally responsible. The recommendations have been prepared having regard to these requirements and in accordance with the 5 ways of working.

3 ANY CONSULTATIONS UNDERTAKEN PRIOR TO RECOMMENDING THE DECISION

3.1 Broad consultation was undertaken through the member workshops, joint meeting of Scrutiny Forum and Cabinet, Management Team, Scrutiny Forum. The recommendations were submitted to the Governance and Audit Committee before submitting to the full Council for a decision.

3.2 THE STATUTORY OFFICERS' OBSERVATIONS:

Monitoring Officer:

The consultative and discussion work that has been undertaken to reach the recommendation is highlighted here. It has allowed consideration of options and reaching a conclusion on the need for change. It also provides a way forward to respond to the recommendations of the Audit Wales report. I confirm that I will deal with the necessary changes to the Constitution resulting from the decision of the Council.

Statutory Finance Officer:

I believe that the decision sought will not create additional spending commitments, and I support the intention to improve the efficiency of the arrangements.
