2.2 What steps have you taken to engage with people with protected characteristics, regarding the Welsh language or with communities (either due to location or due to need), who are living with a socio-economic disadvantage?

No specific engagement has taken place to date but a corporate engagement process has meant that Elected Members have had the opportunity to provide input based on their awareness of their areas and what their constituents are raising with them.

Departments will need to decide what level of engagement will be required to carry out their individual impact assessments and that will feed into the method of implementation.

#### 2.3 What was the outcome of the engagement?

The plan has been developed and co-designed to include members' views.

#### 2.4 On the basis of what other evidence are you acting?

Our capital plans need time to prepare and therefore it is good practice to have a current Plan for an extended period. The budget we anticipate available for capital plans for the next 10 years is £45.2M while departments' requirements are £129.3M. It was therefore necessary to go through a process of prioritisation in order to set a balanced plan

#### 2.5 Are there any gaps in the evidence that needs to be collected?

It is possible that, due to a lack of adequate information, there is an impact on certain features and it is important to look at them individually to identify if a full assessment needs to be undertaken. Of course an impact assessment may have been done on a number of these already.

This is a capital expenditure prioritisation plan, and some of the projects include making improvements to Welsh provision such as the secondary education sector in Bangor.

It is not anticipated that any of the other plans will lead to the Welsh language being treated less favourably than English. In some cases, specific projects or plans within the Asset Plan will be expected as they develop and these assessments will need to identify any further opportunities to promote the Welsh language. The procedure for establishing the Asset Plan takes into account the likely resources available for the next 10 years, and prioritises them based on the risk of not achieving them as Departments' requirements are above the available budget.

The individual plans vary from those that are for the whole of Gwynedd to specific ones and have been subject to assessment to ensure that inequality due to economic - social disadvantage is reduced.

Some of the plans that are recommended to be included in the Asset Plan are specifically designed to reduce inequality due to socio-economic disadvantage. These are detailed in Appendix 1, 2 and 3.
