



Parthed: Llwybrau cerdded drwy dir Ysgol Coed Menai , Treborth, Bangor

Ysgrifennaf i gefnogi ymdrech trigolion ardal Cyngor Pentir i ddwyn sylw at bryderon o gyfyngu ar yr hawl i grwydro y llwybrau drwy dir yr hyn a adnabyddir fel Ysgol Coed Menai (Ysgol Treborth cyn hynny).

'Roeddwn yn Bennaeth ar yr ysgol rhwng 1998 a 2003 a hoffwn gyflwyno y sylwadau canlynol.

Yn ystod y blynyddoedd hynny 'roedd yn arferiad rheolaidd i weld y cyhoedd yn cerded ar hyd y llwybr cyhoeddus o'r ffordd fawr, yr A487, at yr ysgol yna yn parhau ar hyd y ffordd o flaen yr ysgol a thai'r staff cyn croesi pont y rheilffordd ac ymlaen at erddi botanegol y Brifysgol a Phont Y Borth.

Roedd y llwybr yma yn darparu taith hyfryd drwy barcdir hanesyddol ystad y teulu Davies, perchnogion gwreiddiol Treborth. Yn yr amser y bûm yn gweithio yn yr ysgol ni chafwyd anhawster o gael cerddwyr yn defnyddio'r llwybr hwn, ac am y deallaf bu'n arferiad gan drigolion lleol i wneud hyn yn y blynyddoedd blaenorol hefyd.

Rhaid cofio bod yr ysgol wedi bod yn darparu addysg arbennig ac wedi arfer agor ei drysau yn wythnosol yn ystod tymhorau'r ysgol a'r cyfnodau gwyliau i fudiadau'r gymuned megis Marchogaeth i'r Anabl, Clwb Gateway, gwersi lleol yn y pwll nofio a gemau ar y meysydd peldroed ar gyfer ieuenctid cylch Penrhosgarnedd ac ymhellach.

Yn wir 'roedd hi'n arferiad gweld aelodau o'n cymunedau lleol yn defnyddio'r adnodau a'r llwybrau yn gyson yn foddhâd ac yn rhan annatod o weledigaeth yr ysgol i hybu'r dealltwriaeth at waith yr ysgol gyda disgyblion oedd dan anfantais ac y hybu cyswllt cymunedol.

Re: Walking Paths through Ysgol Coed Menai, Treborth, Bangor

I am writing to support the effort of the residents of the Pentir Council area to draw attention to concerns about restricting the right to wander the paths through the land of what is known as Ysgol Coed Menai (Treborth School before that).

I was Head of the school between 1998 and 2003 and I would like to present the following comments.

During those years it was a regular practice to see the public walking along the public route from the main road, the A487, to the school then continuing along the road in front of the school and the staff houses before crossing the railway bridge and on to the University's botanical gardens and Pont Y Borth.

This path provided a wonderful journey through the historic parkland of the Davies family estate, original owners of Treborth estate. In the time that I worked at the school, there was no difficulty in having walkers to use this path, and as I understand it was the norm for the residents of the area to do this in previous years as well.

It must be remembered that the school used to provide special education and used to open its doors weekly during the school terms and holiday periods to community organizations such as Horse Riding for the Disabled, Gateway Club, Local lessons in the swimming pool and games on the football pitches for the youth of the Penrhosgamedd area and further afield.

In fact, it was a normal to see members of our local communities using the path resource regularly which was a satisfaction and an integral part of the school's vision to promote the understanding of the school's work with pupils who were disadvantaged and the promotion of community contact.

Indeed, an open and welcoming attitude towards the public led to interpret that it was completely natural to have access to the paths through the land and that since 1950 when the school was founded.

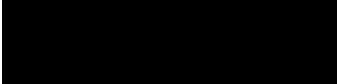

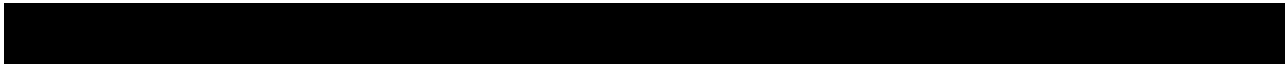
